URGENT door repair; "Receiving Dock Door #2" insulated overhead sectional, approx 8'x8' with full vertical lift track, push-pull operation. Possible impact damage to door, sections off track, cables may be off drums. Opening can be secured. Repair for proper operation ASAP, Security & Safety concerns.

Job Progress Report

2-2 in progress, repair ASAP. 2-3 Tech on site, confirmed Door #2 RH cable off drum. We provided service to correct, we reset the cable back onto RH drum and wound with correct taper. Upper portion of RH vertical 2" track was straightened, aligned & anchored for smoother door operation on open-close. Sections aligned as needed and Door #2 tested OK for proper push-pull operation. Parts lubed as needed. ADDITIONAL Request per Mgrs: Main Dock Door, approx 12'x10' with chain hoist operator hand chair falls off sprockets. We checked door and adjusted torsion spring tension for improved door balance. This helps save the door from closing too fast, throwing chain off hoist operator. Tested OK. Dock Door #5, approx 8'x8' vertical lift, reset roller back on track. All sections are damaged from impacts & use. Recommend 4: new sections for Door #5. Receiving Dock Doors repaired, adjusted and recommendations noted. 2-3 Job Completed.
